We understand the Holland Patent Central School District (the "District") was erroneously omitted from the definition of "Taxing Authorities" in the above-referenced PILOT Agreement, and a copy of such PILOT Agreement was not distributed to the District at the time it was filed with the Town of Marcy Assessor.

We also understand the Agency conducted a public hearing on August 17, 2021 pertaining to the proposed financial assistance granted by the Agency to the Company under the PILOT Agreement.

The District hereby waives the requirement to receive notice of the public hearing, acknowledges receipt of the PILOT Agreement, and agrees to bill and collect PILOT Payments as provided therein.
