

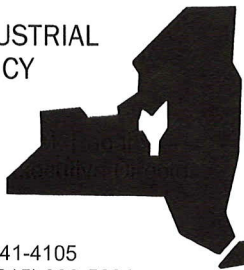

**Re: Notice of Release of Lands from PILOT Agreement dated as of November 1, 2020
Between Oneida County IDA and GLDC**

Dear Mr. Surace:

Please be advised Oneida County Industrial Development Agency conveyed to Griffiss Local Development Corporation by deed dated February 14, 2024 a portion of certain property located at Brooks Road, Griffiss Business and Technology Park (224.000-0001-015).

The IDA no longer owns an interest in Parcel A and Parcel B as described in the deed, but retains ownership of the balance of the property. As such, Parcel A and Parcel B are no longer subject to the above-referenced PILOT Agreement effective February 14, 2024. The PILOT Agreement remains in effect for the balance of the lands owned by the Agency.
